VOLUNTARY ANNOUNCEMENT

INCREASE IN SHAREHOLDING BY THE CHAIRMAN AND SUBSTANTIAL SHAREHOLDER

This announcement is made by Vobile Group Limited (the “**Company**”) on a voluntary basis.

The board of directors of the Company (the “**Board**”) was informed that on 16 July 2021 and 19 July 2021, Mr. Yangbin Bernard WANG (“**Mr. Wang**”), the chairman and substantial shareholder of the Company had acquired on the market an aggregate of 600,000 ordinary shares of the Company at an average price of approximately HK\$8.28 per share, representing approximately 0.03% of the entire issued share capital of the Company as at the date of this announcement (the “**Acquisitions**”).

Immediately after the Acquisitions, Mr. Wang’s shareholding in the Company (excluding share options) increased from approximately 13.80% to approximately 13.83%.
